(b) An ordinance amending Ordinance No. 50-03, Zoning Ordinance of the City of North Canton, to change the zoning of parcels abutting North Main Street and South Main Street, from Orion Street NW and NE to Everhard Road NW and SW, to the Main Street Business District ("MSB"), as more fully described in Chapters 1121, 1123, 1125, 1127, and 1137 of North Canton's codified ordinances, and excepting those certain parcels, clearly illustrated in the Zoning Districts Map attached hereto and incorporated herein, which are not harmonious with the intent of the MSB.
