16 All right. At this time if you would join me
17 in the Pledge of Allegiance.

18 (The Pledge of Allegiance was recited.)

19 MR. PETERS: All right. Ben, would you
20 please call the roll.

21 MR. YOUNG: Member Peters.

22 MR. PETERS: Here.

23 MR. YOUNG: Member Stroia.

24 MR. STROIA: Here.

25 MR. YOUNG: Member Revoldt.

1 MR. REVOLDT: Here.

2 MR. YOUNG: Member Cerreta.

3 MR. CERRETA: Here.

4 MR. YOUNG: Member Werren.

5 MRS. WERREN: Here.

6 MR. YOUNG: Member Foltz.

7 MR. FOLTZ: Here.

8 MR. YOUNG: And Member Fonte. Member Fonte
9 is absent.

10 MR. PETERS: All right.

11 MR. REVOLDT: Move to excuse Member Fonte.
12 Revoldt moves to excuse Member Fonte.

13 MRS. WERREN: Werren seconds.

14 MR. PETERS: All in favor, say "aye."
15 ("Aye" in unison.)

16 MR. PETERS: Opposed? All right. Motion
17 carries.

18 Okay. Ben, do we have anyone speaking
19 tonight?

20 MR. YOUNG: We did not have anyone sign up.

21 MR. PETERS: All right. Very good. Well,
22 then we will move on at this time to old business.
23 May I have a motion and a second to read by title
24 only Ordinance 79-20.

25 MR. REVOLDT: Revoldt moves.

1 MRS. WERREN: Werren, second.

2 MR. PETERS: All in favor, say "aye."

3 ("Aye" in unison.)

4 MR. PETERS: Opposed? All right.

5 MR. CERRETA: Cerreta abstains.

6 MR. PETERS: Cerreta abstains. Passes 5-0.

7 One abstention.

8 Ben.

9 MR. YOUNG: An ordinance authorizing the
10 director of administration of the City of North
11 Canton to advertise and receive bids according to
12 specifications established by the department of
13 administration, and authorizing the mayor, upon board
14 of control approval, to enter into contracts for the
15 completion of those projects and purchases over
16 \$50,000 and budgeted for in the 2021 annual budget as
17 adopted by Ordinance 66-2020 and pertaining to
18 Arrowhead Golf and Event Center.

19 MR. PETERS: All right. Thank you, sir.

20 Chairwoman Werren, the floor is yours.

21 MRS. WERREN: Yep. We have talked about this
22 numerous times and Pat and Jina have both given us
23 really line item figures for these and so this is
24 just to get it done. So I move to adopt.

25 MR. FOLTZ: Foltz seconds.

1 MR. PETERS: All in favor, say "aye."

2 ("Aye" in unison.)

3 MR. PETERS: Opposed?

4 MR. CERRETA: Cerreta abstains.

5 MR. PETERS: All right. Thank you. Passes
6 5-0. Cerreta abstains.

7 All right, folks. That concludes our agenda
8 for tonight.

9 Quick housekeeping measure. Council meeting
10 calendar, January 25 will be committee of the whole
11 and city council. So at this time I'll entertain a
12 motion to adjourn.

13 MR. REVOLDT: Revoldt moves.

14 MRS. WERREN: So moved. Werren. Werren,
15 second.

16 MR. PETERS: All in favor, say "aye."

18 MR. PETERS: Opposed? All right. Motion
