21 Is there a motion to approve the minutes  
22 from May 30th?

23 MR. LANE: So moved.

24 MR. GREENWALD: Second.

25 All in favor?

1 MR. LANE: Aye.

2 MR. GREENWALD: Aye.

3 Approve the proposed date for the  
4 EMT/firefighter entrance exam on July 31st.  
5 Is there a motion?

6 MR. LANE: Yeah. Yes.

7 MR. GREENWALD: Second.

8 MR. LANE: Do you have any discussion on  
9 that? Chief?

10 CHIEF BACON: No. We -- Linda and I  
11 worked on everything. We have the date set.  
12 And she said Clancy is available to do it;  
13 so --

14 MR. GREENWALD: All in favor?

15 MR. LANE: Aye.

16 MR. GREENWALD: Aye.

17 And we have propose for two promotional  
18 exams in early September time frame. Do we  
19 need a motion? Do we need a date?

20 MS. MILLIS: Well, we -- the date we were  
21 given was September 24th.

22 MR. GREENWALD: Is there a motion to hold  
23 the two promotional exams on September 24th?

24 MR. LANE: So moved.

25 MR. GREENWALD: Second.

1 CHIEF MINOCK: I was part of that  
2 discussion. We talked about that, and with  
3 Clancy and the study materials, and the  
4 logistics of giving two of those tests to  
5 basically the same group of people, I'm  
6 wondering if we couldn't just combine those  
7 into one.

8 MR. GREENWALD: That's fine with me. Is  
9 that legal?

10 MS. FARINA: Uh-huh. Yes.

11 MR. GREENWALD: Is there a --

12 MR. LANE: Is it our decision, or since  
13 we already approved the date, is there  
14 something else that has to be done?

15 MS. FARINA: I spoke to Mayor --

16 CHIEF MINOCK: We approved the date for  
17 an exam. In lieu of a change, it would be  
18 for the chief's exam. But if -- it's the  
19 same pool of people. It's the five sergeants  
20 and the lieutenant that would -- except for  
21 one sergeant may not be eligible to take the  
22 chief's test. So it kind of would complicate  
23 the eligibility list, unless you did two  
24 separate ones after the scores came out. You  
25 get what I'm saying?

1 MR. GREENWALD: Uh-huh.

2 CHIEF MINOCK: Because the pool of guys,  
3 all six are eligible for the lieutenant's  
4 position, based on the rule change we made  
5 last time. But only five are eligible for  
6 the chief's position. But unless somebody  
7 thinks that would be a hardship, delineating  
8 the eligibility list for the positions --  
9 because it's my understanding, Clancy is  
10 going to give the same test for both  
11 positions; so --

12 MS. FARINA: It saves money. We don't  
13 have to pay for the two tests.

14 CHIEF MINOCK: Right.

15 MS. FARINA: And we ran it by --

16 CHIEF MINOCK: And we get --

17 THE REPORTER: Wait. Wait. Sorry.  
18 Sorry. Just one at a time.

19 MR. GREENWALD: Well, from a financial  
20 standpoint, we need to save as many dollars  
21 as possible, so we can cover our court  
22 reporter's fees; so --

23 MS. FARINA: We ran this by the City  
24 Administrator, Patrick, and the Mayor, and  
25 they both agreed.


