Ordinance No. 74 - 2018


An ordinance authorizing the supplemental appropriation of funds of the City of North Canton to be appropriated from the unappropriated resources of the General Fund, Fire Operating Fund, EMS Operating Fund, Street Construction M & R Fund, and the Waste Revenue Fund, within various budget line items for the current expenses during the fiscal year ending December 31, 2018.

WHEREAS, it is necessary to appropriate additional funds into the various budget lines within the 2018 budget to cover the City's expenses for the fiscal year ending December 31, 2018.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH CANTON, COUNTY OF STARK, AND STATE OF OHIO:


- Section 1. To provide for the current expenses and other expenditures of the City of North Canton, during the fiscal year ending December 31, 2018, the following funds, be, and are hereby set aside and appropriated as follows, see Attachment "A".
- Section 2. That the Director of Finance of the City of North Canton, be, and is hereby authorized to issue warrants from appropriations established herein for the payment of vouchers duly approved by the proper departmental authority.
- Section 3. That if a provision of this ordinance is or becomes illegal, invalid or unenforceable, that shall not affect the validity or enforceability of any other provision of this ordinance.
- Section 4. That this ordinance shall take effect and be in full force from and after the earliest period allowed by law.
