

ORDINANCE NO. 35-79

An ordinance establishing the rates of compensation for the Recreation Department and Municipal Swimming Pool employees of the City of North Canton, Ohio and repealing Ordinance No. 56-78 adopted by North Canton City Council on May 23, 1978 and Ordinance No. 9-79 adopted by North Canton City Council on January 8, 1979, and declaring it to be an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH CANTON, COUNTY OF STARK, STATE OF OHIO:

Section 1. That there be, and are hereby established the following rates of compensation for the Recreation Department and Municipal Swimming Pool employees of the City of North Canton, Ohio.

Section 2. RECREATION DEPARTMENT

Director	(Exempt)	\$ 13,500.00/yr.
Playground Dir. A	(PT)	765.00/yr.
Playground Dir. B	(PT)	710.00/yr.
Playground Supv. A	(PT)	180.00/yr.
Playground Supv. B	(PT)	165.00/yr.
Playground Supv. C	(PT)	150.00/yr.
Class D Labor	(PT)	2.75/hr.
Class A Instructor	(PT)	7.00/hr.
Class B Instructor	(PT)	6.00/hr.
Class C Instructor	(PT)	3.00/hr.

Section 3. That all provisions of Ordinance No. 9-79, adopted by North Canton City Council on January 8, 1979 and any and all legislation passed previously inconsistent with this ordinance are hereby repealed.

Section 4. MUNICIPAL SWIMMING POOL

Pool Director	(PT)	\$ 2,500.00/yr.
Ass't Pool Director	(PT)	1,675.00/yr.
Head Pool Guard	(PT)	2.70/hr.
Counter Clerk A	(PT)	2.00/hr.
Counter Clerk B	(PT)	1.85/hr.
Class A Guard	(PT)	2.60/hr.
Class B Guard	(PT)	2.40/hr.
Class C Guard	(PT)	2.20/hr.
Class D Labor	(PT)	2.75/hr.

Section 5. That all provisions of Ordinance No. 56-78, adopted by North Canton City Council on May 23, 1978, and any and all legislation passed previously inconsistent with this ordinance are hereby repealed.



This ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the health, safety and peace of the City of North Canton, Ohio, and immediately necessary for the timely establishment of classifications and compensation therefor, in order to enable the efficient operation of the Recreation Department and Municipal Swimming Pool for the up-coming spring and summer season, and shall take effect and be in force immediately upon its adoption and approval by the Mayor.




