

ORDINANCE NO. 45-79

An ordinance authorizing the supplemental appropriation of funds of the City of North Canton, Ohio, to be appropriated from the unappropriated balance of the No. 20 Water Revenue Fund to the No. 20-600 Water Administration in the aggregate amount of \$164,330 and repealing items of appropriation contained in Section 15. of Ordinance No. 44-79 in the aggregate amount of \$48,200 and authorizing the supplemental appropriation from the No. 54 Water Expansion Replacement and Improvement Fund to No. 20-601C Dressler Well Improvement Project, No. 20-601D 6th Street to 7th Street Water Loop Improvement Project, No. 20-601E Glenwood-Freedom Well Improvement in the aggregate amount of \$48,200 for the current expenses during the fiscal year ending December 31, 1979, and declaring it to be an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH CANTON, COUNTY OF STARK, STATE OF OHIO:

Section 1. To provide for the current expenses and other expenditures of the City of North Canton, Ohio, during the fiscal year ending December 31, 1979, the following funds, be, and they are hereby set aside and appropriated as follows:




