

ORDINANCE NO. 79-79

An ordinance authorizing the Director of Finance of the City of North Canton to establish a special fund No. 86 1979 Curb and Gutter Improvement Project Construction Fund, in accordance with the provisions of Section 5705.09 (E), of the OHIO REVISED CODE for the purpose of enabling an accurate accounting of receipts and expenditures applicable to the 1979 Curb and Gutter Improvement Project and authorizing the supplemental appropriation of funds of the City of North Canton, Ohio, to be appropriated from the unappropriated balance of the No. 86 1979 Curb and Gutter Improvement Project Construction Fund to the No. 86-720 1979 Curb and Gutter Improvement Project Construction Fund account no. 86-720-23 Professional Service, account no. 86-720-29 Contract Payments and account no. 86-720-70 Transfers (Intra-Fund) in the aggregate amount of \$63,500.00, and declaring the same to be an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH CANTON, COUNTY OF STARK, STATE OF OHIO:

Section 1. That the Director of Finance of the City of North Canton, be, and is hereby authorized to establish a special fund, No. 86 1979 Curb and Gutter Improvement Project Construction Fund, for the purpose of enabling an accurate accounting of receipts and expenditures applicable to the 1979 Curb and Gutter Improvement Project.

Section 2. To provide for the current expenses and other expenditures of the City of North Canton, Ohio, during the fiscal year ending December 31, 1979, the following funds, be, and they are hereby set aside and appropriated as follows:

Section 3. That the Director of Finance, be, and he is hereby authorized to issue his warrants from the appropriations established herein for the payment of vouchers duly approved by the proper departmental authority.

Section 4. That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the health, safety and peace of the City of North Canton, and immediately necessary in order to enable an accurate accounting of receipts and expenditures applicable to the 1979 Curb and Gutter Improvement Project, and shall take effect and be in force upon its adoption and approval by the Mayor.
