

ORDINANCE NO. 95-79

An ordinance authorizing the Board of Control of the City of North Canton, Ohio, through the Director of Administration, to advertise and receive bids according to specifications now on file in the Office of the Director of Administration and the Mayor to enter into a contract for employee group hospitalization insurance, surgical insurance, major medical insurance, prescription drug insurance, term life insurance and dental insurance for all full-time employees of the City and any part-time officials as may be authorized by the Council of the City of North Canton, Ohio, and declaring it to be an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH CANTON, COUNTY OF STARK, STATE OF OHIO:

- Section 1. That the Board of Control of the City of North Canton, Ohio, through the Director of Administration, be, and it is hereby authorized to advertise and receive bids according to specifications now on file in the Office of the Director of Administration and the Mayor to enter into a contract for employee group hospitalization insurance, surgical insurance, major medical insurance, prescription drug insurance, term life insurance and dental insurance for all full-time employees of the City and any part-time Officials as may be authorized by the Council of the City of North Canton, Ohio.
- Section 2. That the employee group insurance benefit plan premiums shall remain firm for a twelve (12) month (one year) period and any increase in premiums thereafter shall require prior written notification as specified in the bid specifications.
- Section 3. That the Board of Control may authorize extension of the employee group hospitalization insurance, surgical insurance, major medical insurance, prescription drug insurance, term life insurance and dental insurance on a month to month basis for an indefinite period until said Board of Control deems it advisable to readvertise and receive bids for continuation of the employee's group insurance plan.
- Section 4. That the Director of Finance of the City of North Canton, Ohio, be, and he is hereby authorized to draw funds necessary for the payment of the above specified contract from appropriations to the various operating funds of the City applicable thereto.
- Section 5. This ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the health, safety and peace of the City of North Canton, Ohio, and immediately necessary for the timely authorization of the Director of Administration, through the Board of Control, to advertise and receive bids for the employees' group insurance plan, and shall take effect and be in force upon its adoption and approval by the Mayor.




