

ORDINANCE NO. 149-79

An ordinance authorizing the Mayor of the City of North Canton, Ohio, State of Ohio, upon authorization of the Board of Control, to enter into a professional service agreement for the purpose of the furnishing of advice in matters of municipal finance, and declaring it to be an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH CANTON, COUNTY OF STARK, STATE OF OHIO:

- Section 1. That the Mayor of the City of North Canton, State of Ohio, upon authorization of the Board of Control, be, and he is hereby authorized to enter into a professional service agreement for the purpose of the furnishing of advice in matters of municipal finance.
- Section 2. That such services shall be furnished at the request of and under the direction of the President of Council of the City of North Canton which direction shall be within the sole discretion and authority of the President of Council.
- Section 3. That the compensation for said services shall be \$12.50 per hour, plus 16 cents per mile for automobile expenses.
- Section 4. That the Director of Finance of the City of North Canton, be, and is hereby authorized to draw funds necessary for the payment of the above specified contract from the applicable appropriations upon receipt of vouchers duly approved by the proper departmental authority.
- Section 4. That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the health, safety and peace of the City of North Canton, Ohio, and immediately necessary for the timely financial planning of the City, and shall take effect and be in force upon its adoption and approval by the Mayor.

A G R E E M E N T

THIS AGREEMENT made and entered into this 20th day of November, 1979, by and between John Wray and the City of North Canton, Ohio:

W I T N E S S E T H:

In consideration of the following terms and conditions, John Wray and the City of North Canton enter into a contract as follows:

1. The City Council appoints John Wray and John Wray agrees to provide general municipal finance consulting services pursuant to Ordinance No. 149 -79 passed by the North Canton City Council on the 26th day of November, 1979.

2. John Wray shall act at the direction and discretion of the President of Council on the services to be provided to the City of North Canton.

3. Compensation for John Wray shall be at the rate of Twelve Dollars and Fifty Cents (\$12.50) per hour plus sixteen cents per mile for car expenses.

4. It is hereby expressly agreed between John Wray and the City of North Canton that this contract may be terminated at the will of either party upon a Thirty (30) day written notice.
