

ORDINANCE NO. 159-79

An ordinance authorizing the transfer of funds of the City of North Canton, Ohio, from the No. 01 General Fund in the amount of \$10,858.06 to the No. 10 Special Street Improvement Tax Levy Fund in the amount of \$4,624.00, No. 12 Street Construction Maintenance and Repair Fund in the amount of \$5,670.50 and to the No. 15 Special E.M.S. Operating Levy Fund in the amount of \$563.56 for the current expenses during the fiscal year ending December 31, 1979, and declaring the same to be an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH CANTON, COUNTY OF STARK, STATE OF OHIO:
