

ORDINANCE NO. 160-79

An ordinance authorizing the supplemental appropriation of funds of the City of North Canton, Ohio, to be appropriated from the unappropriated balance of the No. 84 Northwest Sanitary Sewer Fund to the No. 84-610 Northwest Sanitary Sewer Construction Fund A/C 84-610-60 Principal in the amount of \$350,000 and A/C 84-610-61 Interest in the amount of \$20,895 for an aggregate amount of \$370,895.00 and appropriating from the unappropriated balance of the No. 98 General Bond Retirement Fund and appropriate to the No. 98-180 G.O. Debt Service, A/C No. 98-180-61 Interest in the aggregate amount of \$8,000 for the current expenses during the fiscal year ending December 31, 1979, and declaring it to be an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH CANTON, COUNTY OF STARK, STATE OF OHIO:

Section 1. To provide for the current expenses and other expenditures of the City of North Canton, Ohio, during the fiscal year ending December 31, 1979, the following funds, be and they are hereby set aside and appropriated as follows:

Section 2. That the Director of Finance, be, and he is hereby authorized to issue his warrants from the appropriations established herein for the payment of vouchers duly approved by the proper departmental authority.

Section 3. This ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the health, safety and peace of the City of North Canton, and immediately necessary for the timely appropriation of funds in order to facilitate the transfer of funds and shall take effect and be in force upon its adoption and approval by the Mayor.
