

RESOLUTION NO. 10-79

A resolution amending Section 5. of Resolution No. 8-78, adopted by the North Canton City Council, January 9, 1978, by the addition of the Community and Economic Development Committee and the deletion of the Planning and Review Committee of North Canton City Council, and declaring the same to be an emergency.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NORTH CANTON, COUNTY OF STARK, STATE OF OHIO:

Section 1. That Section 5. of Resolution No. 8-78, adopted by the North Canton City Council January 9, 1978, be, and is hereby amended by the addition of the Community and Economic Development Committee and the deletion of the Planning and Review Committee of North Canton City Council to read as follows:

"Section 5. COMMITTEES OF COUNCIL

I. The Standing Committees of Council shall be:

1. Annexation Committee
2. Community and Economic Development Committee
3. Finance and Property Committee
4. Garbage and Rubbish Committee
5. Moral Claim Committee
6. Ordinance and Rules Committee
7. Park and Recreation Committee
8. Personnel Committee
9. Safety Committee (Police, Fire and E.M.S.)
10. Sanitary Sewer and Water Committee
11. Storm Sewer Committee
12. Street and Alley Committee
13. Transportation Committee
14. Zoning Committee

II. Committee assignments shall be made by the President of Council at the beginning of each year.

III. Special Committees of Council may be assigned by the President of Council thereafter as needed.

IV. Each Councilman shall present in writing to the President of Council at the beginning of each year, their preference of Committee assignments.

V. The President of Council shall make assignments at his own discretion, but shall take into consideration the seniority of each member, the member's preference of Committee assignments the member's special qualifications and experience and the best interests of the citizens of the City of North Canton, Ohio.

VI. The President of Council shall designate one of the Committee members as Chairman.

VII. The Committee of Council shall meet upon call by its members.



VIII. No Committee shall meet without having first notified its members of the meeting date and time. The Clerk of Council shall send notices which must be received by each member at least twenty four (24) hours prior to the meeting. The Clerk shall enter into the record any failure to notify a member for whatever reason. The meeting may be held even though all members were unable to be notified, if a quorum is present. A quorum shall be a majority of all members assigned to a Committee. Committee members may waive the twenty four (24) hour requirement if there is sufficient cause. However, all members of the Committee must waive.

IX. Members of the Administration may call Committee meetings through the Chairman of the proper Committee. Whenever possible and unless special conditions are present, all Committee meetings shall be held in the evening after 5:00 P.M. This is due to the fact that the position of Councilman is a part time position and Councilmen usually have another job during the day."

Section 2. This resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the health, safety and peace of the City of North Canton, Ohio, and necessary for the immediate establishment of the Community and Economic Development Committee and deletion of the Planning and Review Committee, and shall take effect and be in force immediately upon the adoption and approval by the Mayor.
