**Fire/EMS 2 Captain (Corrected)**

Notice is hereby given that a written promotional examination for the class Fire/EMS 2 covering the position of North Canton Fire/EMS Captain will be held **Thursday, April 15, 2021, at 12:30 PM** in the North Canton Civic Center located at 845 West Maple Street, North Canton, Ohio 44720.

Applicants wishing to take the promotional examination must register for the examination in person and file a completed and notarized Civil Service application with the Secretary of the Civil Service Commission at City Hall, 145 N Main Street, North Canton, Ohio 44720. The filing period begins at **8:30 AM on Monday March 1, 2021**, and ends at **4:00 PM on Friday, April 9, 2021**. There shall be an application fee of \$10.00, payable at the time an application is filed. Applications are available on the Civil Service webpage at [northcantonohio.gov](http://northcantonohio.gov).

The examination is open to all current employees of the City of North Canton who have at least two years of consecutive service in a position classified FIRE/EMS 1. Under this criteria the following full-time employees are eligible to take the examination:

The passing score for this examination shall be seventy percent (70%).


A copy of the suggested reference materials for this examination is attached to this notice.
